1. Call to Order & Roll Call

MPO Chair Constance called the meeting to order at 10:58 a.m. All MPO Board members were present.

2. Public Comments on Agenda Item

There were no public comments.

3. MPO Interim Director – Appointment

Commissioner Chris Constance proceeded to name Principal Planner, Laks Gurram, as interim director. Janette Knowlton stated that there have been no further applicants at this time.

There was brief discussion on the matter of the pay increase. Commissioner Tiseo asked when the pay range study had last been looked at. It was stated that Kathy Quick, HR Director, had conducted a pay range study in the last quarter of 2024. Commissioner Constance asked if there was any other mechanism to increase the pay range for hiring a permanent director, such as the county shouldering any of the funding needed to pay higher. Commissioner Tiseo stated that a 5% increase is not enough for the increase in workload.

Mr. Gurram was given the floor to speak and expressed gratitude to the MPO Board members for the opportunity to appoint him as the Interim Director. He indicated that the promotion is not just about career advancement. He stated that the promotion comes with a lot of responsibility, but also is a great opportunity moving forward. He indicated that coming March will be his 17 years at the MPO. He also reminded the board that it will be a tough time for the rest of the MPO team moving forward and in the middle of LRTP development.

Commissioner Tiseo asked if Mr. Gurram was performing his standard duties at the same time as he would be performing the duties of director. Mr. Gurram answered that he would be. Commissioner Tiseo asked what a 10% increase would be as opposed to a 5%, which Mrs. Knowlton stated could be a discussion point added to the next agenda for the meeting on March 31, 2025.

Commissioner Ken Doherty made a motion to appoint Laks Gurram as interim director with a pay raise of 5%. **Commissioner Tiseo** seconded the motion which passed unanimously.
